## STALL HOLDER AGREEMENT / CONDITIONS FOR STALL HIRE

1. Stall holders must have their own public liability cover of \$20 million. A copy of the Policy must be provided with this registration form.
2. Hobbyist Stall Holders do not require evidence of insurance if they meet the definition of hobbyist.
  - Definition: The Hobbyist cannot have an ABN and must earn less than \$20k a year from their stall holding activity.
  - NOTE Hobbyist stall holders must sign the Declaration at the foot of this application form.
3. Market Stall Space is 3m x 3m.
4. Stall holders will be directed to their site on the day.
5. Stall holders, where appropriate, shall ensure that it is licensed or registered to carry out the activity listed on their registration.
6. Power is not supplied to sites unless specifically stated.
7. Market stalls to be ready to trade for a 9am start on Friday (if trading on Friday) and 8.30am start on Saturday. Sites will be available for set up from 7:00am on Friday morning and from 7:00am on Saturday morning.
8. Hours of operation: Friday 9am till 3pm (optional), Saturday 8.30am – 7pm (set up and pack down times to be advised).
9. Site Fees are for Friday and Saturday unless otherwise indicated.
10. Selected stall holder sites will allow for parking behind the stall.
11. The most visible stall sites do not allow for vehicles parked near the stall. Access will be made for bump in and bump out and vehicles must be removed from the site by 8:00am. Parking is available in the Public Parking Area.
12. Stall sites do not allow for CAMPING.
13. Stall holders to provide their own tables, tents and equipment. All tents must be either pegged or have weights on each corner to ensure the tent does not lift off the ground with a strong gust of wind.
14. Acceptance of, or cancellation of, stallholders will be at the discretion of the organising committee.
15. The stallholder will ensure that its site(s) are left in a clean and tidy condition at the end of the event and all rubbish is removed.
16. In the event of Bad Weather check our website at [www.robertsonshow.org.au](http://www.robertsonshow.org.au).
17. One trade pass entry is included in the price and will be sent prior to the Show.
18. Attendance numbers cannot be guaranteed. No refunds provided due to low attendance rates.
19. No refunds granted should the Show be cancelled due to weather events or unforeseen circumstances.
20. Should the Annual Show be cancelled prior to the advertised date, all fees paid will be fully refunded to a nominated account.
21. No raffles / guessing competitions or unauthorised fund raising to take place unless consent is sought from the Robertson Show Society and granted prior to the show.

### **Insurance Declaration:**

Hobbyist Stallholders: Defined as those who are not running a formal commercial enterprise nor have an ABN and they earn under \$20,000 per year from their stall activity. Those Hobbyist Stallholders who meet this definition and have signed the below declaration are automatically covered under the Show's insurance cover for Public Liability. The ASC's Public Liability insurance does not extend to Hobbyists in any manner for any Products Liability exposure.

I declare that I am a Hobbyist Stall Holder, do not have an ABN and do not earn more than \$20,000 in this enterprise on an annual basis. I am therefore protected under the Show's Liability policy for Public Liability only. I am aware that this protection does not extend to Products Liability.
